4. On August 5, 2010, Reporting Person was awarded a number of PSUs within a preset range, with the actual number contingent upon the achievement of certain performance criteria. The Compensation Committee of the Issuer's Board of Directors confirmed achievement of the performance criteria on February 05, 2014 and, based on that assessment, determined the number of PSUs. The PSUs shall vest on March 1, 2014.
