### Item 5.07 Submission of Matters to a Vote of Security Holders.

On May 17, 2018, SunPower Corporation (the "Company") held its 2018 annual meeting of stockholders. Stockholders voted on three proposals at the meeting. First, François Badoual, Antoine Larenaudie, and Pat Wood III were nominated and re-elected as Class I directors to serve until the Company's 2021 annual meeting of stockholders or until their duly qualified successors are elected. Second, in a non-binding advisory vote, stockholders approved the compensation of the Company's named executive officers as disclosed in the Company's proxy statement relating to its 2018 annual meeting of stockholders. Third, stockholders ratified the appointment of Ernst & Young LLP as the Company's independent registered public accounting firm for fiscal year 2018.
