On October 12, 2012, the Board of Directors of SunPower Corporation ("SunPower") approved a reorganization to accelerate operating cost reduction and improve overall operating efficiency. In connection with this plan, which is expected to be completed within the next 12 months, SunPower expects to eliminate approximately 900 positions primarily in the Philippines, representing approximately 15% of SunPower's global workforce. As a result, SunPower expects to record restructuring charges totaling \$10 million to \$17 million, composed of severance benefits, lease and related termination costs, and other associated costs, the majority of which will likely be recorded in the fourth quarter of fiscal 2012. SunPower expects greater than 90% of these charges to be cash.
