1. The sale reported on this Form 4 was effected pursuant to a previously adopted rule 10b5-1 trading plan by the reporting person.
2. 791,732 shares held by Mr. Dinwoodie are subject to an agreement with SunPower that imposes certain transfer and repurchase restrictions. The restrictions lapse on one quarter of the shares semi-annually during the two-year restriction period, so long as Mr. Dinwoodie remains employed by SunPower. 263,910 shares remain to vest on 1/10/2008, 263,911 shares on 7/10/2008 and 263,911 on 1/10/2009.
3. Price reflects weighted average sales price; actual sales prices ranged from \$90.15 to \$92.00.
